

Declaration of consent for self-testing by means of PoC antigen test
and consent to the processing of personal data

I. Consent to self-testing by means of PoC antigen test

We hereby declare our consent according to § 1629 para. 1 clause 2 sub clause 1 of the German Civil Code (BGB) that our daughter/son

_____, born on _____¹

may test himself/herself in case of a suspected infection with the coronavirus SARS-CoV-2 by means of a PoC antigen test in the areas provided on the school premises for the performance of PoC antigen tests. The consent also includes the demonstration and explanation of the test, as well as the accompaniment and supervision by persons accredited and previously instructed at the school, unless they are sufficiently qualified due to the practice of a medical profession. These persons are in particular, teachers or voluntary administrative assistants, persons working full-time or part-time in a test center (e.g. physicians or employees of welfare organizations).

The PoC antigen test is not an official school test, but a voluntary and free self-test of your daughter or son. A positive antigen test can initially only establish a suspicion, but not already a diagnosis of SARS-CoV-2 coronavirus infection. It is quite possible that after a positive antigen test, PCR testing will result in a negative test result. Nevertheless, all persons who are aware that a self-made PoC antigen rapid test ("self-test") for the presence of SARS-CoV-2 virus is positive are obligated to report this to the supervisor immediately upon learning of this and to go directly to their home. This document therefore also provides you with more detailed information in the event that the antigen test result is positive.

In the case of a negative antigen test result, the result of a self-test always represents only a snapshot. The tests therefore do not provide absolute certainty that

your child is not infected with SARS-CoV-2. Hygiene and distance rules, as well as the requirements for wearing masks, must therefore continue to be observed in the event of a negative test result.

Consent to self-testing using the PoC antigen test is voluntary and can be revoked at any time with future effect. Participation in self-testing by means of the PoC antigen test requires that the school is allowed to be informed of a positive antigen test result after the PoC antigen test has been performed.

This declaration of consent must be signed by both parents, unless one parent represents the child alone, insofar as he/she exercises parental care alone or the decision is assigned to him/her according to § 1628 BGB.

II. Consent to the processing of personal data in connection with participation in the self-testing by means of PoC antigen test.

In addition, we consent to the processing of the following personal data of our daughter or son in accordance with Art. 6 para. 1 sentence 1 lit. a) as well as Art. 9 para. 2 lit. a) of Regulation (EU) 2016/679 (General Data Protection Regulation - DSGVO) for the purpose of detecting a possible infection with the SARS-CoV-2 coronavirus and preventing the spread of the SARS-CoV-2 coronavirus:

- Name and surname of your daughter or son,
- Date and place of birth of your daughter or son,
- Address data of your daughter or son,
- Information about your daughter's or son's school career (school, grade or year),
- First and last name(s) of you as parents,
- Address data of you as parents,
- Test result.

The consent also includes the authorization for teachers and other persons who accompany the performance of the self-testing by means of PoC antigen tests on behalf of or in coordination with the school to view the antigen test of your daughter or your son or to have it handed over to them. Any legal or official obligations according to which you have to report the result of a positive rapid antigen test of your daughter or son to the local health authority (cf. Decree of the Ministry of Social Affairs, Health, Youth, Family and Senior Citizens, as amended, on the "Issuance of General Decisions on the Order for segregation (Isolation or Quarantine) due to

Infection by the Novel Coronavirus (SARS-CoV-2) or the Classification as a Category I Contact Person in a Suitable Home"), remain unaffected by this.

Further information on data processing:

These personal data will be deleted by the respective data-processing authorities insofar as they are no longer required for the fulfillment of their tasks - in particular the guarantee of a required segregation at school or non-participation in school attendance events or the breaking of infection chains.

The school principal of the school your daughter or son attends is responsible for data processing by the school.

As a person involved, you have the following rights if the necessary conditions are met: right of information pursuant to Art. 15 of the German Data Protection Regulation (DSGVO), right for rectification pursuant to Art. 16 of the German Data Protection Regulation (DSGVO), right for data erasure pursuant to Art. 17 of the German Data Protection Regulation (DSGVO), right for restriction of processing pursuant to Art. 18 of the German Data Protection Regulation (DSGVO), right for data transferability pursuant to Art. 20 of the German Data Protection Regulation (DSGVO) and right for objection pursuant to Art. 21 of the German Data Protection Regulation (DSGVO).

Complaints regarding data processing may be submitted to the central data protection officer of the Ministry of Education for the public schools or with the State Data Protection Officer at the Independent State Center for Data Protection, Holstenstraße 98, 24103 Kiel.

If the school becomes aware of a positive antigen test of your daughter or son, it will temporarily - i.e. until proof of a non-infection by a negative PCR test result or a separate decision of the local health authority or an appropriately competent body - no longer allow him or her to participate in lessons and examinations - for which there may be a re-testing date - in the school to ensure that teachers, classmates or other persons are not infected. Your daughter or son will have to leave the cohort immediately after learning of the positive antigen test result. Pedagogical care and accompaniment of your daughter or son is guaranteed for the time of segregation within the school. With your consent to the self-testing of your daughter or your son by means of the PoC antigen test, you undertake to pick up your daughter or your son from the school or have him/her picked up as soon as possible after notification of the positive antigen test result by the school.

Consent to the processing of personal data at your daughter's or son's school is voluntary and can be revoked at any time with future effect. The data processing, including data transfers, carried out until the revocation remains legal.

This declaration of consent must be signed by both parents, unless one parent represents the child alone, insofar as he or she exercises parental care alone or the decision is assigned to him or her in accordance with § 1628 BGB (German Civil Code).

If a student is already of legal age, he or she consents to the processing of his or her personal data to the extent described above in accordance with Art. 6 Para. 1 Sentence 1 lit. a) and Art. 9 Para. 2 lit. a) of the German Data Protection Regulation (DSGVO) and documents that he or she has taken note of all other information in this declaration of consent for the performance of self-testing using PoC antigen tests.
